2. The government grants permission to the concerned institution to start a new secondary school on the condition that all necessary requirements as per secondary school code as well as the following conditions, are fulfilled.

A the concerned secondary school must strictly herea to the government orders issued from time to time (eg. Regarding statement admission)

b. the financial condition of the concerned institution must be satisfactory adequate.

c) For English medium secondary schools, the institution must submit a written guarantee, signed by the institutions president to me concern deputy director of Education that no grant of any kind with be requirement from the government in the tu

3. Before granting this permission ensure the following conditions are certified regarding the concerned institutions.

1) There are no serious complaints against the institution.

2) The concerned institution is registered under the Mumbai Public Trusts Act, 1950 & he societies Registration Act 1860 under the mumbai Public Trust Act. 1950

3) None of the schools run by the concerned institution have had their recognition withdrawn.

4) There have been no complaints about any type of malpractice in the concerned institutions, nor is there any pending case regarding the takeover of any school run by the institution by the government.

4) Necessary actions should be taken immediately as per this order. Additionally, after completing the proess of granting permission to the concerned secondary school, a report should be promptly sent to the government.
